REACH is a regulation of the European Union (EC 1907/2006) that deals with the Registration, Evaluation, Authorization and Restriction of Chemical substances and entered into force on June 1, 2007. The objective of REACH is to improve the protection of human health and the environment through the better and earlier identification of the intrinsic properties of chemical substances. At the same time, REACH is intended to strengthen the innovative power and competitiveness of the chemical industry in the EU.

VENTS products do not contain substances that may be released under normal or reasonably foreseeable conditions of use. Therefore, none of the substances contained in our products need to be notified or registered under Article 7(1) of the REACH regulation.

In accordance with Article 33(1) of the REACH regulation (EC 1907/2006), we are obliged to inform our customers if a product supplied by us contains a substance of very high concern (SVHC) in a concentration above 0.1 % (w/w).

The candidate list of SVHC meeting the criteria in Article 57 and identified in accordance with Article 59(1) of the REACH regulation (EC 1907/2006) is updated twice a year on the homepage of the European Chemicals Agency (ECHA): https://www.echa.europa.eu/candidate-list-table

At the same time, VENTS products may contain substances in concentrations of more than 0.1% (w/w), but these cases fall under the exceptions provided for by the European Union Regulation EC 1907/2006.

Ventilation Systems, LLC will continue to assess and monitor the substances in its products to ensure compliance with REACH. Should any of the substances contained in our articles in a concentration of more than 0.1 % (w/w) be included in Annex XIV or in the candidate list in the future, Ventilation Systems, LLC will forward information about these substances to its customers in accordance with Article 33(1) of EC 1907/2006.
